Dear Friends:

It is with great pride that we present the Fifth Oregon Food Share Annual Report. Our statewide food bank network has made impressive strides in helping Oregon's hungry this past year.

The Oregon Food Share Network's collective distribution totaled 23,929,748 pounds of food. Over 429,000 Oregonians received that food through emergency food boxes; hundreds of thousands of others were helped through supplemental food programs. The numbers of people needing help continued to increase - up 20.5% over 1985 - but the response to that need from Oregonians was also greater than ever.

The Oregon food industry increased its role, with more than 160 food companies contributing this year. Individual Oregonians and non-food businesses were also incredibly generous, working together on several statewide food drives. Clearly, Oregonians are taking action to end hunger in our bountiful state.

Several special donations and accomplishments highlighted the year: •Safeway's donation of a semi truck, •a grant from the Ben B. Cheney Foundation to start our Food Recovery Center, •a very successful statewide training conference for the network member agencies, and •a record number of volunteer hours - 183.000 - contributed to the Oregon Food Share network to help eliminate hunger.

Another important highlight was the Hunger Factors Assessment, a statewide survey of people requesting emergency help through the Oregon Food Share Network. Through the help of Oregon State University, OSU Extension Service, the Governor's office, Linn Benton Food Share and Portland's St. Vincent de Paul a statistically sound study of the hungry was made possible for the first time in Oregon.

The results are sobering and show conclusively that people requesting emergency food are most often families with small children, are very often employed and long time residents of Oregon, and yet are still not making ends meet. In short, they are our neighbors who have fallen on hard times and are struggling to survive. The Hunger Factors Assessment findings also illustrate the crucial role being played by emergency food programs and point to the need to maintain and expand a strong food bank network in Oregon in the years ahead.

Many changes still await us if we are to achieve our full potential as a statewide network. •We must expand our food solicitation program in order to capture donations of thousands of pounds of edible food which are still being wasted. •We must work to assist our network food banks to achieve the highest calibre operations possible through training, technical assistance, fund raising activities and upgraded equipment and storage. •We must take our story to the public, to enhance understanding of hunger and of food banking, as a partial solution to hunger.

Oregon Food Share is based on the simple, yet powerful idea that food should not be wasted while there are hungry people in need.



We want to express our heartfelt thanks to all who have responded to this call with generosity and dedication. Food donors, food bankers, volunteers, "door openers", check writers: it is because of you that Oregon Food Share is a success! Thank you for helping us help Oregonians.

REPORT ON HUNGER IN OREGON

The 523 independent non-profit member agencies of the Oregon Food Share Network provide emergency food to needy inaividuals and families statewide. Requests for emergency food assistance continued to spiral upward to 20,600 WEEKLY in FY 85-86. Of these agencies:

317 are Priority 1 emergency food box programs, (an increase of 20.5% the previous year) 206 are Priority 2 on-site feeding programs and Priority 3 supplemental feeding programs, they served......750,000 individuals (est.)

Ouarterly public distributions of government commodity foods take place throughout the state, they served.......362,025 individuals at least once last year.

THE OREGON FOOD SHARE SYSTEM

Donating food to Oregon Food Share is simple. One phone call to our office is all that is necessary. OFS will either arrange to have the food brought to our Portland warehouse, or in the case of smaller donations, make arrangements for our local Regional Coordinating Agency to handle the food donation. No food donation is too large or too small. OFS has the capacity to handle fresh and frozen food as well as processed food products. Contributions of transportation, and storage for donated food are key to this capability.

Food is handled according to industry standards. Proper food handling and record keeping practices are emphasized in the training provided to member agencies by OFS staff and consulting experts. All agencies are regularly monitored by OFS representatives to assure continuing compliance with operating standards.

Food distribution is equitable. Food donations are allocated to various areas of the state based on low income population, unemployment, handling capacity of the Regional Coordinating Agency, and special needs.

EMERGENCY FOOD AT LEAST ONCE LAST YEAR

Regional Coordinating Agencies

There are 19 Regional Coordinating Agencies (RCAs) in the OFS network. They are independent non-profit organizations that represent a critical link in getting food to the hungry. Each acts as a regional food bank, distributing food to member charities which serve their communities. We appreciate and salute the tireless and inventive efforts of RCA staff and volunteers around the state. In all, 183,000 volunteer hours were provided to RCAs last year.

In addition, Oregon Food Share is assisting the Idaho Food Bank Warehouse in its effort to become a full member of the Second Harvest national network of food banks.

Government Food Distribution

Oregon Food Share has worked closely with State Community Services to manage the distribution of food through the federally sponsored Temporary Emergency Food Assistance Program (TEFAP). Over 12.5 million pounds of cheese, butter, dry milk, flour, corn meal, rice and honey were distributed in FY 1986.

MAJOR ACCOMPLISHMENTS

FOOD RECOVERY CENTER

OFS has established a Food Recovery Center to clean, sort, and recapture food which is damaged in retail stores. The efforts of hundreds of volunteers make it possible to save 80,000 pounds of food a month for distribution to the hungry. Special thanks are extended to Safeway Stores and Fred Meyer stores, the two major donors of this food to OFS, and the many volunteers who work in the warehouse. Thanks also go to the many food brokers who make this food available to OFS. Visitors and volunteers are welcome. Call OFS for an appointment.

THE MAYOR'S BALL

Mayor Bud Clark's inaugural ball in 1985 was such a success the Portland Music Association decided to do it again; this time for the benefit of Oregon Food Share and the Portland member coordinating agency, the Interagency Food Bank. Thirty-six bands played on six stages for seven hours to the delight of 7000 people. A total of \$30,000 was raised to benefit hungry Oregonians. Thanks go to Mayor Clark, hundreds of volunteers, and the Portland Music Association for making it possible.

HUNGER FACTORS ASSESSMENT

The Hunger Factors Assessment was a project developed by Oregon Food Share to help illuminate the socio-economic and political factors that put Oregonians at risk of hunger. The project was sponsored by OFS, Oregon State University, OSU Extension Service, the Office of Governor Victor Atiyeh, Linn/Benton Food Share and Portland St. Vincent de Paul Society. The first phase report was released in September, 1986, and is available through Oregon Food Share.

THE OREGON FOOD SHARE "CAN " CLUB

The OFS "CAN " Club is our way of involving and thanking our special business supporters. The Business Journal has thrown its resources behind the project and published two full page ads encouraging businesses to join the fight against hunger in Oregon. The latest appeal, which appears in the Journal's Top 25 Listings 1985-1986, lists 60 business "CAN " Club members encouraging businesses to get involved by holding an employee-run food drive. As an incentive (and an employee relations tool), employers are asked to make a matching cash contribution based on the food that is collected. Call OFS for more information.

SECOND HARVEST INNOVATION AWARD

During its national conference in Chicago, Second Harvest, the national food bank network honored Oregon Food Share and its Portland RCA the Interagency Food Bank, with its first Innovation Award. The award acknowledges the development of the nation's first statewide network of food banks.

VISTA VOLUNTEER PROJECT

Over 50 VISTA Volunteers have served the OFS network during the past 4 years. Their hard work and dedication were vital to the success of Oregon Food Share. They have raised food and money, recruited volunteers and have been instrumental in establishing many RCAs. This will be the last year OFS will have the benefit of the program. VISTA assignments are time limited and other worthwhile projects are in line for assistance from VISTA Volunteers. Thanks to all VISTAs who have participated in OFS programs and the Oregon State ACTION office for their support.

STATEWIDE FOOD DRIVES

Food drives are a very important way to involve all Oregon communities and their citizens in the fight against hunger. This hands-on experience generates food for local hunger organizations and maintains the awareness that hunger exists in our midst.

Supermarket Saturday: Pacific Northwest Bell and Safeway sponsored this food drive for the fourth year in 1985. The sponsors were joined by U.S. Bank, Kaiser-Permanente, Portland General Electric, Northwest Natural Gas and the Oregonian as corporate volunteers who collected food at supermarkets in Oregon and S.W. Washington on the second Saturday before Thanksgiving. The event has grown to involve many corporate participants. Int 1985 over \$129,000 in food and money were received through the work of 2000 volunteers.

Cans Film Festival: Tom Moyer Luxury Theatres offers patrons an opportunity to view a firstrun film by donating canned food for the price of admission. This food drive has expanded from Portland to the rest of Oregon and several western states.

Let's Bag Hunger In Oregon: This first of its kind statewide food and fund drive involved inserting 460,000 specially printed grocery bags into 16 newspapers throughout the state. The bag asked participants to fill the bag with food, or to write a check, and deposit the food or money at their nearest First Interstate Bank of Oregon. 81,000 pounds of food and \$17,000 were collected. Special thanks go to First Interstate Bank of Oregon, Willamette Industries, Georgia Pacific, Safeway and the 16 participating newspapers.

State Employees Food Drive: The size of the hearts of Oregon's state employees continues to grow. This year's drive collected over 320,000 pounds of food for distribution through the OFS network. Next year's emphasis will be on collecting non-perishable, high quality foods. Sincere thanks to Oregon's state employees.

We have examined the balance sheet of Oregon Food Share, Inc. at June 30, 1986, and the related statements of support, revenue, expense and fund balance, and support, revenue and expense by function for the year then ended. Except as described in the following paragraph, our examination was made in accordance with generally accepted auditing standards and, accordingly, included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

Because of limitations placed on us by the State of Oregon Department of Human Resources, State Community Services Program, we did not examine the fiscal and inventory records of the Regional Coordinating Agency network. Our examination in this area was restricted to examination of selected reimbursement request forms from the Regional Coordinating Agencies.

In our opinion, except for the effects of such adjustments, if any, as might have been determined to be necessary had we been able to examine the fiscal and inventory records of the Regional Coordinating Agency network as referred to in the preceding paragraph, the financial statements referred to above present fairly the financial position of Oregon Food Share, Inc. at June 30, 1986 and the results of operations and changes in its fund balance for the year then ended in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

COST EFFECTIVENESS

For each dollar OFS spends, 25 pounds of food are secured and made available to 19 Regional Coordinating Agencies throughout the state. On the average, OFS provides 50% of the donated food distributed by each Regional Coordinating Agency (excluding government food).
