Thank you for your letter relating your conversation with Len Bergstein. We have reason to believe that although Bergstein may claim Neil's shots at state government as part of their grandiose strategy, it is quite the reverse. Once the Governor reacted, it is easy to say yes, that was our strategy. believe he was coming purely from the standpoint (we have valid reasons to believe this) that it appears to be the popular thing to do, appears to ride well with the general public and it was only coincidental he got a reaction from the Governor. Furthermore, every attached newspaper article would tell you he has done himself no service. One says he chose those he took a shot at "specifically because of their political impact" as well as "if he really thinks state government is shot through from top to bottom with a bunch of administrative drones, he doesn't know much about state government. is the case, he shouldn't be entrusted with the leadership of it."

Another: "Atiyeh may be a handy target, but even Goldschmidt knows his charges don't quite ring true."

Another says "they (Oregonians) may think it is too expensive but they tend to blame the legislature for that -- not the governor. Thus the dry rot label probably didn't strike a responsive chord."

And "Even those who don't like Atiyeh . . . probably don't see him as a 'dry rot' governor. That label just doesn't fit. Atiyeh, if anything, has been squeaky clean and his appointments, for the most part, adequate or better."

I believe the attached article by Joice Booth is right on. Again, it is our belief Norma can make a name for herself by ignoring Goldschmidt's comments completely and simply not responding. In addition, the Nelson Poll would indicate Neil is not helping himself by running against the Atiyeh Administration.

Enclosed, Bill, is a report from State Scanning Network. This may be helpful information for Norma. The Governor's monthly out schedule and his weekly public schedule are already being
