The North Plains Community Center is one of three Centers in the County that are sponsored by Washington County Community Action Organization. Washington County Community Action Organisation is a non-profit private organization that is incorporated in the State of Oregon. It has a contract with the Federal Government to put into effect programs that will eliminate poverty in the county. The Community Center Program is part of this efen local citizens, who are elected at an open meeting. It was they who interviewed and hired the staff. The group is listed at the end of this report, which is an attempt to inform you of what has been happening in the Center over the past several months.

0.0 HMPLOYMENT OFFICE COMES TO NCRTH PLAINS: Since the end of last Octoper the fregon State Employment Service in cooperation with the Community Action Organization has stationed one of it's personnel at the Center in North Plains. Mr. Walt Jaross is at the Center every Monday from 9 A.M. to 5 P.M.. This is an effort to bring the services of the Employment Office to the areas where the need for it is most. It is also an effort to make job hunting a more personal kind of operation where the people could get to know Walt on a personal basis. Mr. Jaross has counselled people who dropped by to see him as well as signing up some of the high school drop-outs for the Job Corps Program. However the lock of any local job openings has been a problem. The situation should get better with the coming of spring. Then it it hoped that the local employers will use the facility of the Center to line up job seekers with jobs.

NEIGHBORHCOD YOUTH CORP PROGRAM: This program is a job program for kids 16 - 20, who are of low income families and want to work. During the summer the program enrolled 16 in-school kids as well as drop-outs. But since the beginning of school the program has enrolled drop-outs mainly. In the past three months the quota of positions for the County was easily filled, the majority of them comming from the North Plains area. The salary is \$1.25/hr, for a 32 hour week.

The twenty-four enrollees, are working in various public supported agencies where they develop job habits and learn job skills such as the Forest Service, Tigard City Hall, Ertension Service, Employment Office, Forest Grove Day Care Center, CAP Centers and Valley Migrant League. Since most enrollees are school drop-outs high school completion classes are required, siz hours class room work is a must. These classes are sponsored through Valley Migrant League and Community Action Program. All enrollees in Washington County are attending or have completed their bigh school requirements.

Interest of the young people is commendable except for a small group who require special supervision and contacts. Also the payment system for N.Y.C. is inadequate and slow. This creates problems for the enrollee. Good workers quit N.Y.C. and seet employment for immediate payment although the jobs may be only temporary. A solution to this is being sought.

CAP and VML have been necessary for the success of the NYC program by providing jobs as well as other services to the enrollee.

INDIVIDUAL JOES: The staff at the Center has made a strong effort to supplement the work of Mr. Jaross, by trying to line up some jobs for the unemployed during the days that Walt has not been at the Center. Again the almost total lack of local available jobs has been a problem. However some out of town jobs have been lined up such as maintenance, nursing home, Sawyers, hursery, Tektronix, and Utility Companies.

Several people were referred to advertised State Civil Service openings. Four people have been referred to M.D.T.A.. One is in training on the Clerical program, and three are being processed for Dental Technician and Clerical.

An effort is continually being made to ask employers to waive if possible the experience requirement and give an employee experience by simply being on the job.

TUTORING PROGRAM: In conjunction with the VML, the Community Center has now a tutoring program for high school drop-cuts. These kids dropped out of school for many and various reasons. and the Center feels that it cannot go on prefending that they do not exist, so they are trying to do semething in a construc-tive way. Sister Mary Guadalupe of the Practiscan Missionary Siguers, is the tutor. Sister has been teaching remedial reading and counseling drop-outs with C-CAP in the Albina District since last March. Like many of the "new" Nuns, Sister does not wear the traditional habit. A gold cross banging from her neck is her only spirtiual emblem. Most of the students are also on the N.Y.C. program. They come to "school" on Tuesdays and Wednesdays from 6:30 to 9:30 P.M.. The approach of Sister is very defini ely not the structured classroom type. It is flexible and unstructured with the needs of the individual student the prime consideration. The aim of the program is to help the student win a G.E.D. diploma. All involved are looking forward to great things from the students.

HOME ECONOMICS CLASSES: In conjunction with the Head Start Mothers Group a Basic Saving class has been offered in the Center on Wednesday morning beginning at 9:00 A.M.. The class is conducted by Linda Bothell, Head Start Parent Coordinator. A very beautiful sewing machine was donated by Singer Sewing Co., Hillsboro, to the Center for the program. The gals have been working on cobbler aprons and children's garments. Special interest topics such as working with knits, new ways to apply zippers, pattern alterations, line and design are planned for the future.

A <u>Knitting Class</u> has been in full swing since last summer. Twelve ladies have signed up for the New Year's session. Mrs. Mays of North Plains is the efflicient and patient teacher. Class begins every Tuesday at 9:30 AM at the Center.

FAMILY HEALTH SERIES: Beginning last September, the Center had its files of a series of three "film-discussions" on Family Problems. "Phoebe", "Meeting the Needs of Adolescence". "Farent to Child about Sex" were the films reviewed and discussed. Mrs. Helen Running, Home Economist, who works with girls who have become pregnant out of wedlock in the Portland School District. led the discussions. She was ably assisted by Mrs. Emelda Jones. and Mrs. Maxine Sweetman.

WELL BABY CLINICS: Thanks to Dr. James Stewart. County Public Esalth Officer, the Genter has conducted two Well-Baby Clinics one last August and one in December. Dr. Thomas Roe and Dr. James E. O'Dea, University of Oregon Medical School, conducted the Clinics and were assisted by the Public Health Nurse from the Washington County Health Department. Some 35 pre-schoolers were lined up. According to the doctors the children were, for the most part, very healthy. The nurses gave immunization shots to the children who needed them. OLP NEWS

Five trips were made to the Eye Clinic at Pacific University.

The staff are now waiting to receive the application forms for the Dental Clinic that is scheduled to open at St. Mary's Home for Boys, Alcha next month. They will forward the applications to the Clinic's Board of Directors who will screen the applicants and give them their appointments.

MEDICARE INFORMATION DAY: Last July Mr. Dale Toll from the Social Security Office in Portland showed a movie and held a question and answer period on the Medicare Program. There was an afternoon and an evening session. The turn-out for both sessions was less that hoped for but those present enjoyed the movie and their many questions were well answered by Mr. Toll.

YOUTH CLUB: Eight kids walked into the Community Center the last weak of July and asked Jim about the possibility of starting a Youth Club in town. A meeting was called for August 3 and 26 kids showed up. Since then their ranks have swelled to 45. Their first order of business was to appoint their own police force to supervise activities. They invited the Mayor and the City Council to the Center and were honored shortly afterwards the Council attending their meeting. They got permission from has been well attended and enjoyed by all. The kids lined up the chaperones. On August 19, they had a very enjoyable day on the beach at Sesside, Oregon.

Recently they have formed a Gun Club. On the 1st and 3rd Monday of this month they are being taught at the Center how to handle a gun and the safety rules that must be observed. Then next month they will move their meeting to the Hillsboro Gun Club's Range where they will do some firing practice.

Recently a Leathereneft Glass was organized by Jim for Beturday mornings, A Largo donation of leather was received from Frontier Leather Co., Sherwood, C.K. Kids lets see those pocketbooks and fancy handbags come off the assembly line.
