Ladies and Gentlemen, Governor and Mrs. Atiyeh.

I am very much impressed tonight to see, "Shokookai" is having dinner with the governor of Oregon.

When I came to Oregon for the first time in 1961, the "Shokookai" then called "Shoshakai" was a small group of people. I went back to Japan and came back here and went back there and came back here again, and all these years I have been watching how "Shoshakai" or "Shokookai" has been doing. Shokookai has really grown up and all these things happened while you are the governor. So you are the special governor for us, Japanese. So, tonight, I would like to present to you a haiku. Haiku-HAIKU is supposed to be one of the shortest forms of poetry in the world. YATOSE HETE OREGON NO SAKURA MI MO TAWAWA

A literal translation of this is;

EIGHT YEARS HAVE PASSED CHERRY TREES IN OREGON (by which I mean Japanese firms in Oregon) THEY ARE NOW FRUITFULL

and now English version which is well refined by Mr. Beck.

SEEDS PLANTED IN MAY GREW TALL IN THE SUMMER SUN FRIENDS SHARE THE HARVEST.
