C ommunity Action Organization has a far-reaching impact on the lives of thousands of low-income people who, in spite of many burdens, are miraculously able to strive for a better life. Nationally and locally, community action agencies are sought out to provide leadership, develop partnerships, and deliver important services to our low-income

communities. Never has CAO been called on more to provide such leadership than during the past year. In response to growing needs, in 1998-99 CAO provided more help to low-income families in Washington County by:

- Serving 33% more women during our first year of operating Opening Doors maternity outreach program; virtually eliminating local hospital emergency room deliveries from low-income, high-risk pregnant women
- Teaching 34% more Head Start children; co-locating 14 classrooms on public school campuses; training inhome day care providers in Head Start curriculum
- Creating and distributing the first comprehensive information and referral directory of social services available throughout the county, so all service providers can quickly and efficiently find help for low-income families

In addition to these programmatic successes, we have taken steps to strengthen the agency's infrastructure by:

- · Re-building our fiscal operations and upgrading our accounting systems
- · Upgrading and expanding our technology support and systems
- Analyzing our development operation and recommending a plan to increase private contributions to better support our programs

Still another accomplishment was having clients share their challenges and successes with members of the community. This past year we made a commitment to capture and share client stories, and created opportunities for lowincome people to speak to key leaders, policy makers and contributors.

As we focus on our work that draws from our core competencies, namely, our genuine care and concern for children and families, we have every reason to be optimistic for the future of low-income families. Because we know that high quality early childhood services result in better outcomes for children later in life, we have devoted two-thirds of our resources to programs that nurture young families and children. This focus will have tremendous pay-offs for the Washington County community in the coming years.

Thank you for being a caring member of the Community Action family. We look forward to our continued work together.

Mission and Service Area

In partnership with the community, Community Action assists low-income people achieve selfdetermination. Community Action Organization (CAO), a private, non-profit agency, is the largest provider of early childhood education, family and child support services, and emergency basic needs services for low-income residents of Washington County. Our vision is to create a community where residents are strong, resilient, involved in the community, and live with dignity and security. CAO is an umbrella organization that operates a variety of programs serving low-income families at many sites throughout the county. Our programs and services include:

Community Resources



EMERGENCY AND HOUSING SERVICES

More than 8,000 Washington County residents face homelessness every year, primarily due to economic reasons. Community Action offers a wide variety of services to prevent homelessness and meet emergency and basic needs. Our programs shelter homeless families; provide transitional housing; combat housing discrimination; and advocate for affordable housing.

Accomplishments-

- Provided 70 families, representing 252 individuals, emergency housing at the CAO Hillsboro Shelter Home.
- More than half of the sheltered families moved into stable housing after 5 weeks.
- Worked with partner shelters to provide an additional 250 families temporary housing.
- Assisted Interfaith Outreach Services with the relocation of homeless residents when the RITE Center had to close.
- Provided 483 families rent assistance to prevent homelessness.
- Referred 2,482 families to obtain emergency food boxes
- Taught 26 tenant education classes that prepared 41 individuals to obtain and maintain housing.

After being evicted from their apartment for failing to make rent, a family of four ended up at the Hillsboro Shelter Home. As shelter residents, they participated in and learned from tenant and parenting education classes. They left the shelter each day by 9 a.m. to look for permanent housing and employment, which they found. The mother praised the shelter's environment: 'It'feels like a home." She said that it allowed them to step back, put their lives in order, and move on.

Community Resources

ENERGY ASSISTANCE & WEATHERIZATION

Many low-income residents of Washington County must choose between going hungry or being cold. Our energy assistance and weatherization programs prevent utility shut offs, lower fuel costs, and allow those in need to stay in their homes.

Accomplishments-

- Provided comprehensive energy conservation education for 141 households, lowering energy usage by an average of 10%.
- Prevented 728 households from losing their heat and utilities by offering financial assistance.
- Weatherized 246 low-income homes.

A woman who cares for her 5 year-old granddaughter lived in a house with no insulation and had only her fireplace for heat. CAO's weatherization program was able to install insulation and a furnace in her house. "I'm so happy now, and a lot warmer," she wrote to CAO. "Thank God for your program. No one cared but you!"

INFORMATION & REFERRAL

CAO offers information and referral to connect people to needed community services to provide eligibility screening and assessment for our various programs, and to assist with basic emergency needs to alleviate short term crisis. CAO also provides referrals to long-term intervention programs to assist families in achieving self-reliance.

Accomplishments—

- Responded to 11,320 calls, representing 16,980 requests for assistance.
- Established IRis as the new county-wide information and referral database.
- Established an I & R provider network and facilitated regular information-sharing breakfasts.
- Created and distributed 752 copies of a comprehensive Information and Referral Directory.
- Partnered with Washington County's One Stop employment and training program.



Child and Family Support





OPENING DOORS

To achieve positive birth outcomes, Opening Doors seeks out low-income pregnant women who are not receiving prenatal care; motivates them to seek care; and provides the needed information, referral and advocacy to enable them to do so. Services are provided by trained lay health workers, who share similar life experiences with the women they serve. Opening Doors works through collaborative efforts of key healthcare providers and insurers in the area.

Accomplishments-

- Provided 408 low-income pregnant women with prenatal care and social services, up 33% from last year.
- 95% of babies born to elients were born with a normal birthweight.
- 49 support group meetings were held.

A KID'S DOMAIN

CAO operates A Kid's Domain to provide low-income families with safe, affordable care for their school-aged children. Program curriculum includes Homework Club, sports, quiet space, arts and crafts, games and field trips.

Accomplishments-

- 157 children received developmentally appropriate care, up 43% from last year.
- 13 children received scholarships.
- 29 field trips were taken, including visits to the Oregon Zoo, Jackson Bottom Wetlands, Audubon Society, and the Washington County Fair.

A single father, who had been unemployed for awhile, came to AKD when he accepted a job. With the help of an AKD scholarship he was able to enroll his child into childcare. The child has been able to make friends and have a nurturing place to go while dad keeps working.

Child and Family Support

METRO CHILD CARE RESOURCE & REFERRAL SERVICES (Metro CCR&R)

Metro CCR&R is strengthening the local child care and education system by providing information, support and education to parents, providers, employers and the community. By increasing parents' and child care providers' knowledge of child development and education issues, we are improving the quality of child care and school readiness in children.

Accomplishments-

- More than 2,000 low-income parents found safe, affordable quality childcare, up 35% from last year.
- More than 34 in-home child care providers and centers received on-site training to promote preschool childrens' literacy through The Learning Circle program.
- 559 childcare providers received training in child development.

ABC SOUP.

ABC Soup is a federally-subsidized program available to registered family child care providers to promote nutritious meals for children in a child care setting. Providers receive education on proper nutrition for infants and children as well as receive pre-planned menus and reimbursement for meals.

Accomplishments—

• More than 380 childcare providers planned and served nutritious meals, resulting in 5,770 children receiving balanced meals.

Early Childhood Education



HEAD START

Head Start is a government-subsidized preschool program for three- and four-year olds whose family income falls below the poverty level. Children enrolled in Head Start receive a physical exam, a nutritional and growth assessment, vision and hearing screening, and social, emotional, and developmental screening. Head Start places a major emphasis on parental involvement by encouraging parents to help out in the classrooms, to serve on the governing board, or take advantage of educational opportunities including literacy, parenting and child development.

Accomplishments-

- Enrolled 529 children in 14 sites throughout Washington County, up 34% from last year.
- Established partnerships with area schools to serve an additional 190 more children and to co-locate classrooms.
- Built stronger ties with Migrant Head Start.
- Fully immunized 97% of children enrolled.
- Completely resolved 70% of all identified health and developmental concerns by year-end.
- Each family, on average, volunteered more than 23 hours in the classroom or participäted at family events.
- More than 530 parent-led activities took place.
- Conducted more than 856 parent-teacher conferences, establishing goals and reviewing each child's progress.

A former Head Start student (Class of 1984) writes, 'Head Start gave me a real love for school and learning." The quality early childhood education she received contributed to years of academic success. She recently graduated from college with a 4.0 gpa and a double major in Computer Operations and Bookkeeping. Currently, she is employed fulltime as a bookkeeper.
