 - Finished plowing in my orchard & traded off my mare Sally & her colt with Mr. B. Hoen for a grey mare which Mr. Nusbaumer bought for him at Fort Vancouver & Mr. & Mrs. Griffin came here on a visit
 - 10-12 Planted corn, cucumbers & squash
- Tended meeting at Mr. Eells Sab
 - 14-15 Tended Probate Court:

- Sab 26 Tended meeting. Catherine was sick
 - 27 Cut corn
 - 28 Went to Doct Belnaps for some medicine for Catherine
 - 29-30 Fixed a foundation to lay my lumber upon
 - 30 Made out my PO Quarterly report
- Oct. 1-2 Tended to the mail & did chores
 - Sab 3 Tended meeting
 - 4 Butchered a beef & let Mr. <u>Tuttle</u> have 349 lbs & Mr. Walker 165 lbs & kept 190 lbs at home
 - 5 Tended to my beef & did chores & Mr. Gunn (?) came here to work
 - 6 Went to Portland & found old Mr. McMillen
 - 7 Came home
 - 8 Tended to the mail & did chores
 - 9 Halled up 2 loads of wood & tended to the mail & settled with Mr. Robert C. Finney (or Kinney?) up to this date
- Sab 10 Tended meeting with my family & Henry C. Raymond came this evening
 - 11 Did chores about home
 - 12 Cut wood in the woods
 - 13 Halled up 2 loads of wood
 - 14 Did chores about home & let out my cows to Henry Raymond for half the butter & cheese & I give him of 4 cows for 1 yr
 - 15 Repaired my trucks some
 - 16 Did chores about home
- Sab 17 Tended meeting & Henry C. Raymod commenced taking care of my cows this evening
 - 18 Did chores & fixed my trucks
 - 19 Went in to Portland & bought a cooking stove for 75 dolls
 - 20 Did some trading & came home

 - 29 Went to Davis mill with a grist
 - 30 Got my grist & came home & tended to the mail. Mr. Naylor took away his little Margaret home

- Nov. 1 Did chores at home & sent Mr. <u>Dryer</u> some butter & eggs & Mr. <u>Burkhart</u> some butter
 - 2-4 Staid at home lame with a boil
 - 5 Tended school district meeting
 - 6 Took my plows to Mr. Ben Catching to get stocked
- Sab 7 Staid at home
 - 8 Worked some at my house & went to Mr. Catchings & got my plows
 - 9 Worked some about my house
 - 10 Did the same & Mrs. Adams came this afternoon
 - 11-13 Worked on my house
- Sab 14 Staid at home
 - 15-16 Halled up 5 loads of wood
 - Rented my farm to Henry Raymond & William Adams. I furnish teams, seed & implements of farming & they give me helf of what they raise in the half bushel in good order, except potatoes they are to be put in my cellar in good order, they having only the other half raised
 - 17 Worked some at my house. My birthday 50 yrs old. God help me to live to thine Honor & Glory
 - 18-200 Worked at my house
- Sab 21 Staid at home
 - 22 Fixed for going to Portland with butter
 - 23 Went to Portland with my butter & sold it for 90 cts per 1bs
 - 24 Did my trading & came home
 - 25 Did chores about home
 - 26 Did the same & paid Omri Parsons 143.41 cts for lumber on the Cain contract
 - 27 Did chores & worked some at my house
- Sab 28 Tended meeting with my family
 - Went to Mr. <u>Tuttles</u> & got 200 dolls of <u>George Y. Davis</u> & gave my note for it & he is to receive the money in Portland that <u>Miltonia</u> Tuttle gets from the <u>Beagle</u> draft on Adams & Co. Express Office & to let Mr. <u>Eells</u> have the money & I sent a copy of the report of the School **B**istrict No. Two to the County Commission
 - 30 Worked some at my house & loaned to Mr. Eells 200 dolls & took his note for 400 dolls
- Dec. 1-4 Worked at my house
- Sab 5 Tended meeting

- Dec. 6-8 Tended Probate Court
 - 9 Kept thanksgiving with Mr. Walker
 - 10 Did chores & butchered a beef
 - ll Did chores & sold Mr. John Reasoner 463 lbs of beef & let him have my team to take it home
 - Sab 12 Staid at home
 - 13 Tended the funeral of Lydia Flett & then went & had a settlement with F.W.Brown
 - 14-15 Did chores about home & tended stock
 - 16 Tried to get to Mr. Geigers but could not get there
 - 17 Worked some at my house
 - 18 Tended to cattle & did chores
- Sab 19 Tended meeting at Mr. Walkers
 - 20 Cleared the snow off the bridge & worked at my sled
 - 21-22 Hunted for my cattle & worked at my sled
 - 23-25 Worked on my sled
- Sab 26 Staid at home
 - 27 Did chores about home
 - 28 Hunted up my cow & calf
 - 29 Took Mrs. Smith & Geiger to Mrs. Walkers to Maternal meeting & helpt Mr. Naylor hunt up the wild cattle
 - 30 Did chores about home
 - 31 Thus closes up another year. O Lord, forgive the past & give Grace for the future
