<u>EMPLOYMENT</u>: Thirty job referrals were given this month. We helped place fifteen of these in jobs. We now have seven full time NYC girls and one boy working part time for our office. The girls are learning restaurant and fountein operations, cashiering, and help with arts and crafts classes in the Youth Center.

HOUSING: Eight more families are applying for low-income loans to purchase homes. Three families who applied for home loans, have had their loans approved - two in the Sherwood area, and one in the Garden Home, Metzger neighborhood. These three families are now living in their homes.

We have requests for rentals for several families. Anyone knowing of rentals may call the Tri-City Center, telephone number 625-6893.

<u>GED</u>: Classes have been temporarily discontinued. We plan a new class, beginning sometime in July. Anyone interested in attending a GED class can get further information at the center and register for the planned class.

CLINICS: A well-child clinic is scheduled for Thursday, July 24.4 We hope to have an Innunization Clinic at the same time.

ABUADANT FOOD: Abundant food was picked up and delivered to thirteen families during the last month.

<u>CLOTHES CLOSET</u>: Thirteen persons received clothing this month. We are still receiving requests for boys clothing, especially size 10. We also need bathing suits in all sizes for both boys and girls.

SPECIAL ACTIVITIES: A turkey dinner was held at the Old Methodist Church in Sherwood, on June 14. A profit of \$93.57 was realized after expenses.

<u>YOUTH ACTIVITIES</u>: The Board of the Youth Center met on Wednesday, June 18. It was decided that the youth would take on the project of cleaning the main streets of Sherwood. The date for this project will be Saturday, July 12.

A discussion panel made up of members of the 4-C Steering Committee will appear on hCM-TV, Channel 8, Sunday, July 27, at 9:00 a.m. on <u>Sunday Scope</u>, a regular public scrvice program on that station. Mombers of the panel are Ruth Berger, Director - West Tuality Day Care Conter; Doris Rosin, Director - Aloha Retarded Children's Center; Marietta Sorensen, Supervising Murse with the Washington County Health Department; and John Ulrich, Head Start Director - Washington County Community Action Organization and Chairman of the Washington County 4-C Advisory Committee. The moderator will be Mr. Bob

The panel will discuss the general concept of Community Coordinated Child Care, its needs and possibilities, and its application in Washington County from the standpoint of the individual panel member's particular part in the over-all subject of child care and early childhood development. As background material there will be several minutes of color film taken at various child care centers, as well as color slides of children in action.

The program was arranged by Mr. Jim Colley, of Broadcast Counseling Service and is an outgrowth of his offer at the 4-C Workshop in June.

Betty Carter, of the Washington County Children's Dental Clinic, has just returned from San Diego State College where she attended a summer session from June 16 through June 27 on "The Disadvantaged Family and Community Agencies". The following is a report on the course from Mrs. Carter:

"The course, "The Disadvantaged Family and Community Agencies' was attended by sixty-nine students, many teachers, some social workers and college students preparing to work in service fields. Mrs. W. Edwards, from Texas Tech University, Lubbach, Texas, was the

One purpose of this close was to explore the agencies dealing with 'the less chance' families. We had speakers from a Neighborhood House, The United Community Service, the Physide Settlement House, the Chicano Internacial Committee, and a parent of a mentally retarded and emotionally disturbed child.

The second purpose was to define the disadvantaged and learn about them, their living conditions, their feelings and attitudes. There is no prescription, no set steps to follow. The suggested method is to be aware of their needs and the problems of living, for these we hope to serve. An understanding of oneself and our motives were expressed as being essential, if we are to reach the 'less chance'. To help someone means giving of respect and a desire for knowledge, they can learn to help themselves. The goal should help agencies and the disadvantaged working together, making life healthier and happy for

ŧ.

Center was a natural choice for me. This Dental Center has been in operation for 17 years. It takes care of families not on Welfare but who can pay a minimal fee for dental service. The support and organization was very close to the arrangement in Washington County. Some good ideas and information were gathered from this visit.

Outside reading and written reports were also expected as part of this class. One quote from 'Low Income Life Styles' by Lola Ireland, sums up the discussion very well: 'The entire life situation of the poor must be considered if any part of it is to be changed. Their attitudes arise in no vacuum but are logical results of real circumstances. Nothing which the community does for them can be durably effective until they are a functioning part of the community. Energetic patience must prevail. The alienated adult cannot be re-educated. His children can be somewhat swayed, but it is with his grandchildren that one can really have hope.'

A last point and a very important one is the realization that agencies must work together with a continuing, stable program which unites and supports the workers in these agencies."
