DIRECTOR'S CORNER

Over the past month, we have been very active in the state legislative processes providing important information about the needs in our community and the services that we offer. The Community Action Partnership (CAPO) of Oregon held its Education Day on January 28th and Lisa Brown, Renée Bruce and I participated. Lisa set up a table in the Galleria to share information about our work in Washington County. The state released the 2008 Poverty Report with a press conference that we attended. I talked about the increased demand for our services, particularly in rent assistance, and the huge gap in our ability to help due to lack of resources. Did you know that by the end of January we had received 1,131 calls for rent assistance from families with eviction notices? But our current funding only allowed us to serve 45 of the callers. Later, we visited eleven of our legislators to talk about the increased needs we are seeing as a result of the current economic impact and how state funding supports our services. We provided them with a copy of the newly released state poverty report. Since 2000, poverty in Washington County has increased 38.2%, while the county population has increased 17.3%.

Washington County's cost of living is among the highest in the state. The report indicated that a two-parent family with three young children needs an annual income of \$65,868 to pay for basic needs. Wow, no wonder so many people are struggling to get by.

Directors' Corner continued

On February 5th, the Oregon Head Start Association (OHSA) held their legislative day. We had a group comprised of parents, staff and Ralph Brown, from our board that participated and talked about the positive impact of Head Start. One of our Head Start Policy Council members, Tu, was quoted in the OHSA Newsletter saying "I believe that Head Start is the most important factor that can break generational poverty by helping and training parents so that parents help their children. I understand the importance of this message because I, myself, and the only one of three generations of my family to get a bachelor's degree." On both days we had a warm reception by our legislators. In spite of the challenging budget time, they graciously expressed appreciation for our work and the difference we are making.

And yes, these are incredibly challenging economic times. While Community Action is expecting cuts in our state funding, we are also preparing for the possibility of major increases in our federal funding. As you know, Congress is working on an economic stimulus bill. Both the House and the Senate versions include funding for Community Action (CSBG), Head Start, Energy Assistance and Weatherization. The intent is to have a plan that is "Targeted, Timely and Temporary." So we are busy planning for increased services and a rapid response to meet more of the growing need while contributing to increased economic activity through job creation and the purchase of goods and services. In many ways, this is Community Action's time to shine. We know the struggles people are having; we know how to deliver services effectively and efficiently; we have key partners in place for needed collaborations; and we know how to be nimble and responsive in tough times.

The workload is intense, but instead of turning people away, we hope to be in a position of saying "Yes" to many more people. And at the end of the day, fighting the causes and conditions of poverty is what Community Action is all about!







Easy Pesto Pasta

You can make your own pesto or use store-bought pesto sauce for this simple recipe. Be sure to refrigerate leftover pesto and use within a couple of days.

- 4 ounces thinly sliced pancetta, cut into small strips 12 ounces rotini pasta
- 1 cup pesto
- 2 tablespoons finely chopped fresh parsley
- 1 tablespoon pine nuts
- 4 sun-dried tomatoes in oil, drained and chopped
- 4 tablespoons grated Parmesan

Heat a small skillet over medium heat. Add the pancetta and sauté until crisp, about 5 minutes. Transfer to paper towel-lined plate to drain. Cook the pasta according to directions on the box. Remove from heat and place in a bowl. Add the pesto to the pasta and mix well. Add the cooked pancetta and toss to combine. Top with pine nuts, parsley, sundried tomatoes, and Parmesan. Serve at room temperature.



Self Assessment

The Head Start program is in the middle of our annual self assessment process. This process involves the collection of information from a variety of sources to determine if systems and services have been implemented and are working effectively. We have community volunteers, board members, Community Action employees, and staff working with us to conduct site visits, ride the school buses, do file reviews, parent surveys, etc. The information gathered will then be analyzed and the results used to identify program strengths, weaknesses and areas for change and improvement. We are able to use the results of the self assessment to develop meaningful program improvement and provide the foundation for building program excellence.

CHECKS & BALANCES

Fiscal -

Mileage Reimbursements:

We will not pay mileage that is turned in more than ninety (90) days from the date of travel. Please be sure to turn in your Travel Reimbursement Requests promptly; as a rule of thumb, try to turn your mileage in at least once a month.

Mileage is reimbursed at \$.55 beginning on 1/1/09 (it was \$.585 before then). Please be sure you are using the correct form. If you have a mileage form showing any amount other than \$.55 in the lower right portion, dispose of that sheet and get a current one. It is available on the Common drive at I:\Fiscal Info\Fiscal Forms\Travel Reimb 2009. Be sure the copy you turn in to fiscal is on goldenrod paper and filled in properly and signed in ink.

W-2s:

W2's were mailed out 1/29/09. If you still have not received yours, please contact Javier at 503-357-6054 x740.

Purchase Orders:

Once you have used a purchase order at a store such as Fred Meyer, Hank's, Craft Warehouse, etc, you need to turn in the receipt to Fiscal within five (5) days. In the case of purchase orders used for shipments, like Discount School Supply, etc, the packing slips must be sent to Fiscal within five (5) days from receipt of the shipment. If there is a backordered item, note it on the packing slip.

If your purchase order is more than thirty (30) days old and still not used, return it to Fiscal. If you still need the purchase order you can attach a note asking us to reissue it with a more current date. If you know, at the time you are requesting the purchase order, that you will not be using it until a particular date, put that information on the request for the purchase order. That way we can date it for that date and there will be less risk of the purchase order becoming too old before you have a chance to use it. Whenever possible, please request your purchase orders at least two weeks in advance of your requirement date.
