# DIRECTOR'S CORNER

August 20th marks a very special day in the history of Community Action. This is the day, in 1964, that President Lyndon B. Johnson signed into law the Economic Opportunity Act, thus launching a national war on poverty. A national anti-poverty plan soon followed and Community Actions were rmed.

The 1960s were a time of sweeping social change and issues of poverty were at the forefront. John F. Kennedy shed light on the appalling effects of the abject poverty he observed as he traveled the country during the 1960 Presidential primaries. Issues of equality and opportunity were to play a significant role in the Kennedy administration. In fact, the concepts for Community Action were introduced by President Kennedy. Following President Kennedy's assassination, President Johnson made a commitment to carry forward this work. Johnson's domestic platform, called The Great Society, was a proposed set of programs focused on the elimination of poverty and racial injustice.

To give you some perspective on just how important this time was in our Country's history, these are the major pieces of legislation enacted in the 1960s:

- Civil Rights Act of 1960
- Equal Pay Act of 1963
- Civil Rights Act of 1964

- Economic Opportunity Act of 1964
- Voter's Rights Act of 1965
- Age Discrimination Act of 1967
- Civil Rights Act of 1968

It was during this time that race, gender, age and economic status were formally removed as barriers to education, housing, jobs, health care, and other social and economic opportunities. Of course change did not happen over night and discrimination is still something that can diminish the rights of individuals in our country, but these laws created a foundation for communities to work together to chart a future that offered every citizen the chance to succeed.

So much has happened in the 45 years since President Johnson stood before Congress and said: "... This administration today, here and now, declares unconditional war on poverty in America. I urge this Congress and all Americans to join with me in that effort." Through this call to action our own Community Action agency was formed in 1965 to address issues of poverty at the local level. Today, literally tens of thousands of lives have been changed because of our work at Community Action. Certainly it hasn't always been easy and there have been many challenges along the way, but I am proud to say that we have always remained steadfastly committed to the Community Action promise and to our mission.

At the end of this month, I will be heading to Philadelphia for the Community Action National Conference. Renée Bruce, Lisa Brown, Katherine Galian and Ron Sarazin will be joining me. The 45<sup>th</sup> Anniversary of the Economic Opportunity Act will be commemorated during the conference. There will also be many exciting sessions, including a presentation by our Board Chair, Ron Sarazin. In addition, Lisa will be serving on a panel to discuss resource development in Community Action. Here are some water-saving tips to consider:

# CHILD

ludies show that educational achievement gaps already exist at Kindergarten entry. Children from low income families are more likely to start school with limited language skills, health problems and social and emotional problems that interfere with learning. The larger the gap at school entry, the hard it is to close.

Language proficiency is a key predictor of school success. Early literacy skills (size of vocabulary, recognizing letters, understanding letter and sound relationships) at kindergarten entry are good predictors of children's reading abilities throughout their educational careers. Language and literacy skills enable children to develop cognitive skills and knowledge and to interact effectively with peers and adults.

This year, our Head Start program has received additional funding to provide greater literacy experiences for our children and their families. The funds will be used to purchase books so that each classroom can have a well stocked

lending library. Research shows that the single most important thing parents can do with their children to ensure success in school is to read to them at home. Books will be purchased in multiple languages to meet the needs of our families. We will also use the funds to purchase multi ultural clothing, food, and dolls to be



used in our dramatic play areas, musical instruments and CDs for music and movement activities, and flannel board stories for literacy rich language extension and scaffolding.

It is a very exciting time for our Head Start and we appreciate the opportunity to strengthen our program.

## HR - from Nicole

I was wery pleased to see that Oregon recently joined a handful of other states who are leading the way to ensure that all children have adequate health insurance. I think that most



of us would agree that healthy children tend to become healthy adults and often influence their parents and/or guardians to adopt healthier ways of living.

According to the Healthy Kids website, this program provides:

- Free or affordable health care for children 18 and younger.
- Coverage, even for children with a medical condition.

- Medical, dental and vision care; regular checkups; preventive care; prescription drugs; mental health and chemical dependency services; and medical equipment and supplies.

Below are a few tips for checking to see if your family qualifies for this benefit in case you want to seek supplementation to the benefits already offered through your employment with Community Action.

As of today, children in families with income up to 185% of the Federal Poverty Level (FPL) (\$40,792.50 for a family of four) can enroll and beginning in October 2009, coverage will extend to children in families up to 200% FPL (\$44,100 for a family of four).

The online application is located at this website: http://www.oregonhealthykids.gov/. Another option is to call 1-877-314-5678 to have an application mailed to you or to ask for information.

Community Action will contribute to the overall state fund that will enable this coverage and we will contribute whether any of our employees use the benefit or not. In fact, we won't even know if anyone uses it because it's completely unrelated to our own benefit programs. I strongly encourage you to check it out and apply if it's a fit for your family because we want your children to be as healthy as they can possibly be!

# FAMILY & COMMUNITY RESOURCES



### Child Care Resource & Referral:

Did you know that non-licensed (exempt) child care providers who are being paid by DHS to take care of children **may** qualify for free training?

The DHS Enhanced Rate Program is a program that pays providers a higher reimbursement rate because they have met the requirement for Step 1 of the Oregon Registry: Pathways to Professional Recognition in Childhood Care and Education.

The Oregon Registry is a voluntary, statewide program to document and recognize the professional achievements of people who work in the childhood care and education profession.

In order to receive the Enhanced DHS Rate, a provider needs the following:

- Current Infant & Child CPR certification
- Current First Aid certification
- A current Food Handler's Card
- Attended a 2-hour class on Recognizing and Reporting Child Abuse and Neglect

A non-licensed (exempt) child care provider can call 971-223-6100 or 800-624-9516 for more information on this program.

You will experience a warm and safe environment where you can feel comfortable sharing experiences and learning about parenting.

#### Weatherization:

Weatherization presents Energy Education workshops for income-qualified residents throughout Washington County. Workshops are held at the Hillsboro Main Office, at the Beaverton Library, and at the Tigard Library. They are presented in either English or Spanish. Workshops run October through May. Each household attending the workshop receives a \$25.00 credit on their electric bill and a kit of energy-saving items, including compact fluorescent light bulbs, thermometers, and faucet aerators.

We are changing our sign-up system this year to assure that people qualify and have not attended a workshop before. Energy Assistance will have the workshop schedule, but their clients will need to call **503-906-6550** to register.
