Packwood Fiasco

My phone is ringing off the hook from folks like Len Forsgren, Blake Hering and Jim Stever (PNB). All are calling expressing concern about the rumor that you are going to challenge Senator Packwood. In tracking down each of the rumors, Packwood staffer Elaine Franklin in Portland is the one going to all the perceived friends of yours expressing the fear of your challenging Packwood. She is also assuring each and every one that there is a poll in the wind and they are convinced that the poll will show that Atiyeh would not have a chance in beating Packwood. Therefore, the party should not split itself over two long-time Republicans.

Of course this all stems from the recent fracas between you and Packwood. Elaine Franklin is now on a witch hunt. I have refused to share names with her, but she is insisting that we provide Packwood staff names who were involved in scheduling both your visit to Washington as well as the telephone call. You know that I personall do not agree with placing blame nor do I believe in witch hunts. It is unfair to any staff member who has been placed in an embarrassing position by that staff member's boss to try to lay the blame at that person's feet for the purpose of either getting rid of the staff member or making life untenable.
