Spirit Awards Honor Market, Health Advocate, Homelessness Leader

Blustery weather outside the Oregon Zoo Ballroom on the evening of April 1, belied the warmhearted gathering at Community Action's 11th annual Celebration of Community Spirit banquet. Nike served as the presenting sponsor for the event, which attracted 180 guests. In all, \$45,665 was raised through table sponsorships and guest donations.

The Community Spirit Award honors a community partner, business leader, and corporate partner demonstrating exceptional support for the mission of Community Action and for making an exemplary commitment to strengthening our community.

Award Recognizes Opening Doors Program for Prenatal Health Care Outreach

Community Action's Opening Doors program received the 2009 Washington County Public Health Recognition Award, presented April 9 during a ceremony at the Shirley Huffman Auditorium in the Charles D. Cameron Public Services Building in Hillsboro.

Opening Doors provides prenatal health care outreach to low-income pregnant women in Washington County.

During 2008, 100-percent of babies born with the support of Opening Doors had healthy birth weight, with 100-percent enrolled in the Oregon Health Plan.

Challenge. Opportunity. These two words really sum up what we are currently experiencing at Community Action. Our challenge is to meet the rapidly growing need for assistance from families hard hit by the recession, while at the same adapting to flat or even decreased program funding. Our opportunity is to maximize the impact of resources made available through the American Recovery and Reinvestment Act (otherwise known as the Economic Stimulus Package), as well as funding generated locally by concerned residents and local initiatives such as the Community Relief Fund.

First to the challenges: Our phones are ringing, our lobby is full, and our shelter waiting list is long. People from all walks of life are finding themselves facing financial challenges that just a few months ago were unimaginable. They are turning to Community Action for help and for hope. At the same time, we have been watching anxiously as the State of Oregon wrestles with closing the funding gap on the current budget and adopting a balanced budget for the next biennium. With the economy still in decline, the budget will most likely be balanced by significant funding cuts to critical services. These are difficult decisions and there are no easy solutions. There is no doubt that some of our programs will be affected. In addition, many of our private donors have had to scale back, reducing our ability to plug the holes in the safety net. With resources diminished by the current crisis, it is painful to imagine how families in need of health and social services will get by. Yes, these are definitely challenging times.

Now to the opportunities: As challenging as these times may be, Community Action has never been more relevant to our community. We are uniquely positioned to deliver American Recovery and Reinvestment Act services intended to help families hardest hit by the recession. In fact, Community Action is already geared up to accommodate supplemental funding and well positioned to stimulate our local economy through job retention and growth. In particular, expansion of our home weatherization program will create new jobs, pushing dollars into the economy as vendors are contracted to undertake the home improvements associated with this program. Carpenters, electricians, and other trades people who have struggled to find work in recent months will be employed. As supplies are purchased, manufacturers and retailers will see sales increase and they, in turn, may be in a position to bring people back to work.

At the same time, United Way of the Columbia-Willamette has joined forces with local Community Action agencies in Multnomah, Washington, Clackamas and Clark counties, along with the Oregon Food Bank, to launch a special initiative. The *Community Relief Fund* will help families in the four-county area who have been hardest hit by the economic crisis, by raising dollars to immediately provide for basic needs, and helping families to get back on their feet. As the Washington County partner, Community Action will utilize these funds to provide much needed rent assistance to local families with 72-hour eviction notices. We are committed to maximizing every opportunity to grow the safety net to help struggling families and strengthen local communities.

There is no question that these are extraordinary times of challenge and opportunity that will demand much of our organization. If ever there was a time to step forward to lend a hand, the time is now. In spite of the impact the economy is having, so many concerned neighbors have generously donated to Community Action knowing the difference our services are making to those who have even greater needs. We hope you will join them in making a financial contribution today, at whatever level you can. We know that with our community behind us, we can provide the right mix of services to help people through the difficult days ahead. Thank you for caring.

As Economy Falters, New Poverty Population Emerges

The Westside Economic Alliance recently reported that Washington County is shedding 53 jobs each day. Growing unemployment and under-employment have created a new population of economically insecure families in Washington County. Many are seeking assistance for the first time, hoping for help with basics like rent, food and utilities, and they have no idea how to navigate an over-burdened social services system. They are turning to Community Action for both guidance and direct support. In the words of one family recently assisted by our organization: "If not for Community Action, our family would be living in our car or on the streets. Community Action has been our lifesaver."

Young At Art - Budding Artists Learn, Create, Stage Show in Orenco



Karla Castillo, Community Action Head Start Teacher at Orenco Elementary, believes that children learn a lot from creating art and studying artists' work. She said her Young At Art project "took on a life of its own" after she introduced students to artists such as Russian Expressionist Wassily Kadinsky, Abstract Expressionist Jackson Pollock, French Impressionist Claude Monet, Chinese disabled artist Xi Fu, and others. Students painted using techniques the masters used, Castillo said. Kadinsky listened to music while he painted, and he preferred primary colors, so students followed suit. Xi Fu painted with a brush held between his feet, so students tried that, too. The result was an art show at Orenco Elementary on March 5. "Parents were amazed," Castillo said.
