Community Action Organization Celebrates Its 35th Year

S ome thirty-five years ago, in response to Lyndon B. Johnson's "war on poverty," hundreds of private and public community action agencies were established under the Economic Opportunity Act to "eliminate the causes and conditions of poverty" in local communities.

"Community Action has taken on issues of poverty one family at a time," says Jerralynn Ness, executive director of Community Action Organization, which turns 35 in October of 2000. "We have successfully helped more than 12,000 economically disadvantaged families a year win battles over financial hardships and assist them on the road to self-sufficiency."

What began as a modest operation thirty-five years ago has grown into Washington County's leading provider of programs and services for the low-income population of Oregon's fastest growing and wealthiest county. Community Action remains best known for Head Start preschool, one of its original programs established in the late 1960's as a significant tool to break the cycle of poverty for young families. Between 1973 and 1985, CAO added community self-help programs, including a wood co-op and the nation's first agricultural gleaning program. In addition, CAO offered programs in energy assistance and weatherization, operated an extensive volunteer center, and purchased and operated a homeless shelter. In 1989, CAO opened its Neighborshare Office in Tigard, serving lowincome residents in the east part of Washington County.

In 1993 the community contributed \$3.3 million to CAO to fund the construction of a much-needed multi-purpose facility where CAO is now housed. The facility serves as a central office location for the agency and has been instrumental in improving service delivery. Clients now come to one location to receive information and assistance regarding housing, rent and utility assistance, access to weatherization programs, and referrals to services provided by other agencies.

Today Community Action operates programs and provides services at 27 sites throughout the county, including its newest programs, Opening Doors maternity outreach and A Kid's Domain, before and after school care. CAO programs rely on over 800 volunteers annually including those at Play It Again, a volunteer-operated clothes closet. A sampling of recent successes includes serving 33% more women during the first year of operating Opening Doors, teaching 34% more Head Start children, and creating and distributing the first comprehensive information and referral directory of social services available throughout the county.

"CAO has always responded positively to pressing community needs," says Ness. "The services we offer are publicly subsidized and require a significant commitment of private funding. Even with the support we receive

from corporations and friends, we've learned that we need to expand our efforts to increase private support and to continue to critically evaluate how we can best serve those in need at the lowest cost."

What will the next 35 years bring? "Increased collaboration among social service agencies and more partnerships with private funding sources to remain responsive to the needs of the growing population in Washington County," predicts Ness. "Because we work so closely with the community, we feel ready for the challenge."

Community Action is 35 years young! This coming October marks a milestone for our agency as we celebrate three and a half decades of history with our partners throughout Washington County who have worked tirelessly to assist low-income families.

The year 2000 also marks the 25th birthday of our Hillsboro shelter home that began providing safe, temporary housing and support for homeless families in 1975. Each year the shelter serves more than 70 families, representing 275 individuals, half of whom are children.

WESTCO celebrates an anniversary this year as well. Non-profit organizations, churches, and individuals founded the WESTCO fund five years ago as a "safety net" fund which CAO distributes to low-income residents of Forest Grove and Cornelius in emergency situations. Hillsboro churches recently founded a similar fund for Hillsboro residents, modeled

after the WESTCO fund.

Over the years, CAO has offered these and many other programs to help our low-income neighbors, and each program has been successful because of community partnerships and volunteer efforts. In the coming months we want to thank everyone who has helped support our mission of assisting low-income families achieve self-determination (see celebration schedule on the front page) and bring more partners and volunteers into the fold.

We also want to brief each of our supporters on how Community Action is restructuring some of our programs to stabilize needed services for low-income families. We believe these changes will strengthen Community Action's position as we move ahead to our next 35 years allowing us to provide greater opportunities for low-income families to achieve a better life. We look forward to your continued support!

CAO Changes Lives One Family at a Time

Energy Assistance Program Gets \$1 Million Boost

CAO's Low Income Energy Assistance
Program (LIEAP) prevents utility shut offs,
lowers fuel costs, and allows those in need to stay
in their homes by providing financial assistance as
well as comprehensive energy conservation
education. Last year CAO was able to lower
energy usage by an average of 10% in 141
households and to keep 728 families from losing
their heat and utilities.

Despite these accomplishments, the demand for assistance has always been greater than available funding. Recognizing the unstable nature of funding for LIEAP, Oregon legislators passed Senate Bill 1149 into law in the summer of 1999 to increase funding for energy assistance.

Community Action Organization will receive \$1 million to distribute to low-income families in Washington County who need energy assistance to stay warm and keep their utilities running.

Many thanks to Representatives Bill Witt, Ryan Deckert and Ken Strobeck for their support of this bill and the low income protections.

Meyer Trust Awards \$250,000 for CAO Advancement

The Meyer Memorial Trust has granted Community Action Organization a \$250,000 grant over three years to invest in the agency's development program in order to increase private contributions from the community for core services. The funds will help implement a commissioned development plan that emphasizes cultivating major donors and stepping up community relations efforts to better educate the community about CAO.

"Like the clients we serve, CAO struggles to make ends meet," says Margaret Eickmann, CAO board member and chair of its resource development committee that submitted the grant. "This funding will help us build our capacity to better help ourselves help others. We need more private support for our programs and increased involvement of our community if we are to continue to be successful."

The grant will fund the staff and programs needed to build relationships that will result in more support of the critically-needed services CAO provides to the growing low-income population of Washington County.
