Debbie has done amazing things in her life by taking her problems and facing them with strength, grace and a lot of humor. She speaks to thousands of people every year to consistent rave reviews and standing ovations. Her message is simple: "See people for who they are on the inside." It doesn't get more basic than that and it doesn't get more true.

Pumpkin Turnovers

- 1 cup canned pumpkin
- 1/4 cup brown sugar

- 2 teaspoons ground cinnamon
- 2 teaspoons pumpkin pie spice
- 2 sheets frozen puff pastry, thawed

Preheat an oven to 350 degrees F (175 degrees C). Line two baking sheets with parchment paper.
 Mix pumpkin, brown sugar, cinnamon, and pumpkin pie spice in a bowl.
 Roll out puff pastry into a 12x12 inch square and cut each sheet into 9 - 4 inch squares.
 Spoon pumpkin mix into center of pastry squares; wet edges of each square with water, fold over, corner to corner, and pinch edges together. Place onto prepared baking sheets.
 Bake in the preheated oven until pastry is puffed and golden brown, about 15 minutes. Cool on the pans for 10 minutes. Remove to a wire rack and cool completely.

Have you ever looked at your paystub and wondered where you should pick up the book of strange translations so you can actually read it? Me too! Our friends in Payroll sent me these "super secret" codes and I thought I'd pass them along to you.

Remember that your "wage amount" equals your "total earnings" minus "taxes" and then minus "payroll deductions." Depending on the health care and retirement selections you've made during open enrollment, you might see a combination of these labels on your paystub:

Community Action's Housing and Homeless Services will be conducting the 2009 "One Night Shelter/Homeless Count" during the last week in **January 2009, or 1/25/09-1/31/09**. The data that is collected is useful to our county to determine where there are gaps in our homeless services continuum. Then we use that information to support requests for funding from HUD that will provide services to specific homeless populations, or areas of need. Collecting unduplicated information on the number, characteristics, and service needs of homeless people is a critical component of local homeless planning and program development.

Community Action and our partners use the information to:

- Justify requests for additional resources.
- Plan future services that will be relevant to unsheltered homeless people.
- Allocate resources to service providers or programs for different subgroups of homeless people.
- Understand changes in trends among homeless populations.

Each year we apply new strategies that will help us improve the accuracy of this important count. Last year we worked with several churches in the county, who have been willing to open their doors during the week of the count, and we plan to also work with them again this year.

In addition, Washington County's 3rd Annual Project Homeless Connect will be taking place on Wednesday, January 28, 2009. This event is also a crucial component of our count strategy.

Our grants manager Katherine Galian, and Annette Evans of the Dept. of Housing Services, will be in charge of our shelter bed capacity and utilization count. This will cover all spaces in the county that are currently serving our community with bed space for people without living arrangements.

Each of the county's school districts will give unduplicated numbers that will reflect all children that are attending school, and who have been identified as homeless.

We need help in all areas of the count, but where we face the greatest challenge, is in the actual "street count" category.

Volunteers are needed that are willing to go out into the streets an rural areas of the county, and account for as many people who are homeless as we can find. If you would like to participate as a volunteer, you can attend our next planning meeting on
