

### **OPENING DOORS GETS WELCOME MAT**

"Ten fingers, ten toes; a healthy 7 pound 10 ounce baby boy!" Those were the only words Shelly heard the doctor say. It all seemed like a dream. Only a few short months ago the thought of having a healthy baby would have been improb-



able. Shelly had left an abusive relationship with two young children, some clothes and a couple of stuffed animals in an old, pathetically unreliable car.

She came to Washington County to stay at a friend's apartment. She had no job, no money, and no medical insurance and had not seen a doctor even though she was three months pregnant. Shelly was scared that her baby would be born tiny and sickly like its brother. She felt like a failure and was terrified when she would look to the next week and see nothing.

One day while she was sitting in the laundromat, she noticed a flyer on the bulletin board about a place that says it helps low-income pregnant women. Feeling desperate, she called. "Opening Doors," a friendly voice answered, beginning a relationship that would change her life.

Opening Doors was formerly a program of Healthy Start, Inc., which began as a joint venture of public and private health care organizations in 1989 to address the needs of low-income pregnant women and to assist health care providers with resources and education about issues that affect their low-income patients. On July 1, 1998, Community Action became the parent organization of Opening Doors, a program which since 1995 has reached out to over 550 low-income pregnant women in Washington County to help them have healthy babies. In 1997 alone, 362 new clients were served, with all services provided in Spanish and English.

Working from three full-service offices, two paid employees supervise a dedicated staff of seven AmeriCorps VISTA workers who scour neighborhoods leaving fliers in laundromats and stores, searching for women who have dropped through the cracks in the system. Having roots in the community and sharing similar life experiences, VISTA workers are able to understand and empathize with their clients. Their training as lay health workers provides clients with excellent resources as well.


The VISTA worker who answers Shelly's call begins the process of determining her eligibility for the Oregon Health Plan and

walks her through the application process. At least twice a month, usually much more often, the VISTA worker sees her, offering much needed friendship and support as well as education and referrals to other helpful resources such as schooling and childcare. She brings some baby clothes and helps Shelly find a support group for abused women.

The numbers tell a story of pregnancies at risk: 65% of the women are single mothers; 72% haven't finished high school; 33% are teens; 32% smoke upon intake; and 30% are former or current alcohol or drug users. Yet once they receive services from Opening Doors and needed medical services, over 90% of the women deliver healthy babies.

As Shelly holds her new baby, Justin, they both have a future to look forward to. It has become a dream come true.

The ultimate goals of the program are to encourage healthy birth
