History

This organization was incorporated in the state of Oregon 10/13/65 as a nonprofit corporation and is tax exempt under IRS Section 501 C(3) Federal ID #93 0554941 State #NP 76736.

Washington County Community Action Organization, Inc. (WCCAO) is part of a national network of Community Action Program (CAP) Agencies that were created as part of the WAR ON POVERTY in 1965. Originally, the federal government sent funds directly to the CAP organization to operate anti-poverty programs such as HEAD START, VISTA and others. From 1974 through 1981 this federal funding came through the Office of Economic Opportunity and the Community Services Administration (CSA). Since 1982 the programs of the Community Action Agencies have been funded from the state level through the State Office of Community Services (SCS). Additionally, WCCAO receives funds from county, city and other regional governmental entities to help the needy in Washington County, Oregon.

The organization is governed by a volunteer board of 18 directors and 18 alternates that represent three sectors of the community:
