Dr. Harold L. Wilensky, a professor at the University of California, Berkeley, gave his views at the National Confer-ence on Social Welfare at the Conrad Hilton Hotel.

POVERTY PROGRAM ASSAILED-BY G.O.P.

Coordinating Group Calls Drive a Sham Battle

WASHINGTON, July 7 (AP) -Republicans accused the John son Administration today of fighting a sham battle instead of a genuine war against poverty.

The Republican Coordinating Committee, composed of governors, Congression.... ers, state legislators and National Committee members. called for drastic revision of the antipoverty program.

They urged reorganization of the Office of Economic Oppor-tunity, which directs the program, enlarging the roles of state and private industry, and giving top priority to help ing the children of the poor.

Attacked in House

Similar recommendations were made recently by Republicans on the House Education and Labor Committee in attacking a bill written by committee Democrats, which would author-ize \$1.75-billion to carry the antipoverty program through its third year.

The approach favored by the coordinating committee would stress educational programs, employment training, tax incentives for participating business and equal opportunities for the poor.

"It has always been the Republican approach," said the committee report, "to assist the poor and disadvantaged in their climb up the economic and social ladder; not to drag them up forcibly by a green rope of dollar bills."

The Republican program, by requiring heavier contributions from the states, would produce \$2.4-billion for the various antipoverty activities, as compared with \$1.75-billion under the bill now before the House. The Federal commitment under the Republican bill would be \$1.4billion.

Previous Opposition

Republicans have fought unsuccessfully to revise antipoverty legislation in Congress each year since the program started, but this time they feel their chances for bringing about major changes are improved.

A lack of enthusiasm in the antipoverty agency for the House bill has muted the Ad-ministration's lobbying efforts. The bill would put sharp limits on agency spending and transfer some of its administrative duties to other agencies.
