Community Action Will Focus on Housing First

There is growing public awareness of the need to address homelessness in Washington County. Passage of the Washington County Public Safety Levy in November provides essential operating funds for the network of family shelters, including Community Action's Hillsboro Family Shelter, the Domestic Violence Resource Center, Family Bridge, and Good Neighbor Center.

A grant from Kaiser Permanente through the Northwest Health Foundation will help Community Action improve services to homeless families. A three-year \$200,000 grant will fund implementation of the Housing First program model.

As a result, more Washington County families will receive the housing and support services they need to avoid becoming homeless. Housing First has been nationallyrecognized for its effectiveness at

ending the cycle of homelessness. Housing First works on two levels. It focuses staff attention on providing housing and case management to help families achieve stability and self-sufficiency. Housing First also addresses homelessness on a systemic level, seeking solutions by building

relationships with community stakeholders such as private businesses, community development corporations, housing authorities, and government agencies. Community Action's mission is to work in partnership with the community to



A Letter to Our Friends—

We are pleased to send you our "2005-2006 Report to Our Community," enclosed in this edition of our newsletter. More and more families in Washington County are struggling to make ends meet, due to increases in rent and energy prices, as well as child care and health care costs that are beyond their reach. Community Action is proud of our ability to help so many families in need. Community Action was able to respond to over 27,000 requests for help last year. In addition, we increased our activities to educate the broader community about local issues of poverty and how everyone can be a

part of the solution. We produced a media presentation called "When Working Isn't Enough." We joined with the Vision Action Network to sponsor the first "Economic Livability Summit," a forum for business leaders to learn more about how they can better support their low wage work force. At the forum, we introduced a new document for employers titled "20 Things You Can Do For Your Employees." A copy of that document can be found on our web site: www.communityaction4u.org (go to "poverty info" and click on "Employer Resource Guide").

We joined "One Economy" in supporting the launch of a local "Beehive" (www.beehivehillsboro.org) for the Hillsboro community to find "help for a better life." Homelessness issues were in the forefront during 2006 (please read our cover story). Community Action joined a grassroots, inter-faith initiative in west county to raise awareness about homelessness and build support for shelters. We trained thirty volunteers to help with our annual "one night homeless count," giving a more accurate count of 1,155 homeless people in Washington County on a single night, about three times previous counts.

Community Action continues to be a model of responsible stewardship. During fiscal year 2005-2006, we received outstanding financial audit and program monitoring reports. We strengthened our financial status and exceeded our fundraising goals. "I Give Where I Live," our collaboration with other local non-profits, received the Willamette Valley Development Directors Crystal Award for Outstanding Philanthropy Project.

Community Action continues to provide the hope and help needed for families to achieve better lives and greater economic security. We welcome your help to increase public awareness of poverty concerns, and build the Public Will needed to address local causes and conditions of poverty. Together we can improve our community and make it a better place for all to live. Thank you for your concern for people in need and support for our work.



Weatherized 181 homes to increase efficiency and lower energy costs






