



Dear Senator Hatfield:

I urge you to support the Community Services Block Grant (CSBG) program. The CSBG program supports many vital services for low income families across Oregon. The board of Oregon HEAT is very concerned that any cuts in funding for CSBG will critically damage the capacity of Oregon's Community Action Program (CAP) agencies to deliver these important services. Without CSBG funding, CAP agencies across Oregon would have to eliminate many of the core services and programs that Oregonians take for granted as the social service safety net.

I am concerned that your honorable colleagues in both the Senate and the House have persuaded themselves into believing that non-profit agencies in local communities can make up the difference in funding if the CSBG program is reduced or eliminated. Speaking with the authority of ten years of non-profit fund raising experience, and as the Executive Director of the largest non-governmental source of low income energy assistance in the state, let me assure you the fond hopes of your colleagues cannot be realized in Oregon. To put it bluntly, the private non-profit sector in Oregon does not have the capacity to replace Federal funding - not even close.

These circumstances are not a consequence of any lack of concern among Oregonians for people living in poverty. Indeed, your neighbors at home are quite generous where helping their low income neighbors is concerned (Oregon HEAT's receipts have risen by 20% this year alone). However, the giving capacity of your constituents is already approaching its upper limits, and the need continues to grow. Poverty in Oregon is a serious, growing, and expensive issue that can only *begin* to be addressed by the work of important non-profit organizations like Oregon HEAT. The CSBG program has been exemplary in its delivery of services with a minimum of red tape and low administrative overhead. Continued funding for this program is critical.

I urge you to play your part in protecting low income Oregonians from the disastrous effects of cutting the CSBG program.

It is critical that despite the desire to "balance the budget" and "eliminate the deficit" that Congress preserve the Community Service Block Grant program that provides core funding for Community Action organizations around the country.

I am writing to you today as a Board Member of Washington County Community Action Organization (WCCAO), serving the nearly 40,000 low income people living in Washington County, Oregon. These are the key reasons that it makes good economic and social "cents" to preserve CSBG and, even, expand its funding:

- CSBG funds have a multiplying effect, in fiscal year 1994-95 WCCAO received \$159,638 in core funding from CSBG, which has allowed us to leverage nearly \$4 million in other funds to help address the causes and conditions of poverty in our community
- Because Community Action is community-based and locally controlled, we are flexible and able to respond to local needs
- CSBG funds have been used as seed money to operate programs to meet needs that are particular to our area; for example, WCCAO has established a emergency family shelter home, organized and operated a county-wide food bank and expanded the availability of affordable child care and housing with CSBG funds as seed money
- Administrative costs are extremely low, for fiscal year 94-95,
 WCCAO's administrative costs are at 7 1/2% and have never been above 10%

- Community Action is a self-help program; our motto is "a hand up, not a hand out"; program beneficiaries are given the tools and support to help themselves
- We advocate for partnerships between private, public and the volunteer sectors of society, creating collaboration and greater efficiency at addressing the problems of poverty in our community
- I am one of over 500 volunteers that annually donate time to WCCAO. The agency also receives thousands of dollars of in-kind goods and services to help address local needs

Representative Furse, please do your best to help preserve Community Action through your support of funding for the Community Services Block Grant. Not only in Oregon, but in the entire nation, those who are most at risk are depending on you. And two-thirds of those low income people are children.
