On October $9 - 11^{\text{th}}$, the Community Action Directors of Oregon (CADO) held it's co-regional conference, "Bridges Out of Poverty". The conference took place at the Red Lion Inn at Jantzen Beach, which enabled our agency to send quite a few staff to the conference. Katherine Galian, Grants Manger (formerly the Homeless Children's Program Coordinator at the Shelter) was on the Conference Planning Committee and developed the Homeless Education -Children, Youth & Families track. The workshops in that track were excellent - Thank You Katherine! Sharon Bolmeier, Head Start Project Manager was one of the presenters in the workshop - Programs to Strengthen Families with Incarcerated Parents. Sharon discussed the Early Head Start program model that we operate at the Coffee Creek Correctional Facility.

A Hint for Healthy Grocery Shopping

Recipe of the Month

In recognition of Sandwich Day, here is an interesting recipe for a sandwich that Earl John never thought of.

Chicken-Apple Sandwich

Makes 4 1/4-cup low-fat mayonnaise 8 slices whole-wheat bread (or bread to your taste)

2 cups cooked chicken breast, sliced

2 apples, peeled and sliced

8 lettuce leaves

Toast the bread if you want to. Spread mayonnaise on all eight slices. Layer four slices of bread with equal amounts of each remaining ingredient, top with second slice of bread, and serve. For an after-Thanksgiving sandwich, substitute leftover sliced turkey.

HR - Ask Winnie Benefits, Diversity...



Wow, its October all ready – soon it will be Christmas!! This of course

means that Jan. 1st will also be on us very soon and that is normally the time folks think about their retirement savings plan.

A frequent concern of employees is when they look at their check stub to check the amount the agency is contributing to their account it doesn't appear to be the same dollars as in the Handbook.

To accurately determine if what is being put in your account by the agency is correct, you must take the number on the paycheck (for that pay period), and then multiply it by 26 (the number of pay periods) to get to an annual amount, and then divide that number by 12 (months). You should see the same monthly amount that is in the Handbook for your years of service. If not, then call me so I can find the problem. The fact that we have 26 pay periods can be confusing on this sort of information. If you are not in the plan and wish to enter the plan for employee contributions, please contact Nancy Peters (or anyone in HR) and ask them to send you a packet. It is never too early to put money aside for your retirement – the trick to having as much money as you want is letting the money remain in the account year after year. It is the amount of time the money is in the account that makes money for you.

SAFETY

Have you heard of "ICE"?

Short for "In Case of Emergency", programming ICE numbers into your cell phone's address book could help in emergency service workers contact your loved one in an emergency.

In with the rest of your address book numbers, you can include at lease one "ICE" number. Examples: ICE Wife, ICE Dad, and ICE Friend. Then, should something happen to you paramedics, hospital emergency room personnel, police, and other emergency service workers could look in your cell phone's address book for the programmed "ICE" numbers. This saves them from sifting through all the numbers and still not being sure whom to call.

Energy Assistance

PGE's New Start arrearage (high balances) forgiveness pilot program has created quite a buzz in energy assistance. We have referred close to 50 of our clients with high arrearages to this program.

We are getting ready to send out our senior and disabled mail out applications for the 06-07 heating season. This year we have approximately 1200 households that will receive these applications.

In addition to our mail out program our community partners will begin the energy assistance outreach to their clients in late November.

Thanks to all our hard-working intake workers who are collectively juggling 300 plus phone calls we receive daily and working individually with approximately 12 clients daily, who are many times in very crisis oriented situations. We are looking forward to another year of success, keeping our Washington County, low-income residents warm, safe, and healthy with energy assistance.
