Dear Governor:

A copy of your communication has been brought to our attention on the issue of the cult invasion of Antelope. Oregon. It is regettable that you consider it a totalitarian action to secure the U. S. Constitution, in the terms of its founding Christian faith, which is and always has been the basis for common law, the moral order which protects orderly believers against invading corruption. It is difficult to find any basis for your excuse for not expelling such invaders, since your Oath is based on the Christian faith, which arouses the question of who can any who are not of that faith fulfill the Oath to "guarantee a Republican form of government, and secure against invasions" of our borders and institutions? To take a passive position is unConstitutional, because the hostilities and the lawlessness of the group is well-known nationwide. By violating the Constitution, you have given "aid and comfort to the enemy," Fourteenth Amendment, Sec. 3, as well as Art. 4, Sec. 4. Such impeachable offenses do not find any excuse in your insensitive statement, and its irrelevancy to the matter that you will not employ totalitarian means, when the Constitution is ABSOLUTE, indisputable. If you equate the Constitution to TOTALITARIANISM, then you should submit your resignation, for how will you in competence, and through Christian ethics, which are the principles of the Constitution fulfill your Oath to the taxpayers and God that you will defend against anything which will "change the existing order ... "

To permit such invasion of the anti-Christian is to perform by the standards of the Soviet Constitution. According to court precedence, "SECULARISM IS UNCONSTITUTIONAL. PREFERRING THOSE WHO DISBELIEVE OVER THOSE WHO DO BELIEVE... SECULAR PASSIVITY IS UNCONSTITUTIONAL...IT IS THE DUTY OF GOVERNMENT TO DETER NO-RELIGION BELIEF...ATHEISTS DO NOT INTERFERE. THERE IS NOTHING COMPATIBLE. THEY GO THEIR OWN WAY, "without invading our moral order, peace, and safety of society.

You have disserviced the nation, permitting the invasion within your border. Since you do not comprehend the Constitutional Oath, a copy of its meaning is enclosed for you careful study and adoption. This is a Christian nation, and IT IS ENTITLED TO A CHRISTIAN ADMINISTRATION, and those who have no knowledge, obligation, or loyalty to the U.S. and its Constitution, cannot

fulfill the Oath, and should submit resignation. Your refusal to address the obligation with duty due society, and defense due God & Country, by your "I do not propose to institute totalitarian government..." is a violation of the establishment Christian neutrality clause, "The facilities of government cannot be used to commit inhibiton, handicap, hostility, jeopardy, oppression, offense, prohibition to religious principles (Biblical morality- Christian priority)" because these values structure the Constitution, institutions, and laws.

Your position, tolerating, and accommodating invading militant international atheism is support for the Soviet Global Conquest. This is, indeed, comfort and aid to the enemy by the standards of the indisputable mandates of the U.S. Constitution, and the clarifications of the U. S. Supreme Court, and the free will of WE THE PEOPLE, whose country you are placing, like your own services, disservices AT RISK:

You are urged to reconsider the indifference, and disinformation in your letter of March 11, 1983, and to present your loyalty to God & Country without manipulations of materials to justify your support for such actions which do offend and place in jeopardy the priority of Christian faith as our common law!

Please respond with your corrective actions, for it is not merely the State of Washington, but the U. S., and it is not merely the local details, but the U. S. CONSTITUTION - better identified as the threat to national security. Is it your ention to stray and betray your country by irresponsible passivity and ignorance of what the details of the Constitution mean? The brochure will provide those vital details. When I became Governor, I took an oath to support the Constitution of the United States and of the state of Oregon. This oath is a matter of public record, and I do not believe it is necessary for me to indicate further where my loyalties lie.

Included in that oath is a pledge faithfully to execute the law. Under the law, the state of Oregon has no authority to expel persons from its jurisdiction, however unpopular their views may be. This is particularly true in cases where no one has shown, in specific detail, how such persons might be violating the law.

I oppose totalitarian government in all its forms, and I do not propose to institute totalitarian government in Oregon in order to combat totalitarianism elsewhere. That would be like burning down one's own house to put out a fire.
