Community Action has never been more relevant! Last week our incoming board chair, Ron Sarazin, and I attended the National Community Action Legislative Conference in Washington DC. We had an opportunity to meet with our new Senator, Jeff Merkley as well as with Senator Wyden's staff and Congressman Wu. They are all very supportive of our work and the role that has been carved out for Community Action in the American Recovery and Reinvestment Act, commonly referred to as the economic stimulus bill. Every year when I go back to DC to talk to our elected officials, I have always described Community Action as a national network that is flexible, nimble and able to carryout federal anti-poverty initiatives. If Congress needs to get something done at the local level to address issues of poverty, we are the organizations to work through. And that is exactly what is happening with the federal response to our economic crisis. We are in line to receive increased funding for Weatherization, Head Start, Community Services Block Grant and probably a few other areas where we have partnerships developed. Planning for growth and a rapid response is challenging, but this is an amazing opportunity for us to demonstrate what we can do and to be able to help many more people in need.

I attended a day long session on "The Future of Social Service Programs in the

Do you ever wonder about the impact teachers have on children? Our Head Start teachers have the opportunity to make a difference in the lives of their students and families every single day. Here is a story about a child in the Tualatin Head Start and the positive influence the teachers had on the entire family.

At the beginning of the school year there was a student of concern. His teachers were concerned about his behavior and worried about the safety of the other children in the classroom. They worked together and came up with a plan. Through daily routines, rules, and positive discipline the child's behavior began to improve at school. The Teacher II/ Family Support staff helped mom get the support she needed through LifeWorks NW and the child began to change at home also. There was consistency between school and home which affected positive changes.

Today this child is a great friend in the classroom. The teacher II/FS was in the library where she saw his parents. They talked to her and asked how their son was doing in school. She reported the positive steps he had been taking and asked how things were going at home. Dad's response was the child had turned his school rules into home rules as well. He instructs the rest of the family on using nice words at home, not screaming at each other, and the need to use "walking feet". He also has his own circle time at home and reads books to his family. The father explained that he didn't have much school and he wants his son to succeed in school. He asked how he could help him more.

Perhaps in 20 years this child will be a Head Start teacher! It is because of the dedication of the classroom teachers and the support of the entire program that this child and his family are able to make such constructive changes in their lives. So if you ever find yourself wondering about the difference you can make in the world remember this story.

Hi all,

This is a quick summary of what's going on in HR:

Compensation

We've finished our wage comparability study with the help of Dianne Burt-Greene from the MBL Group. We look forward to rolling out new grades and salary ranges by the end of this fiscal year. Each employee will receive a customized letter that describes the placement of your position in the new salary structure and where your current rate of pay is positioned within the range.

Benefits

We've received preliminary cost forecasts for health and dental insurance for the next fiscal year and are currently in the process of analyzing impact to program budgets. The Director's team made the decision to move Open Enrollment to November so that new benefits will begin on January 1, 2010. We are also investigating the possibility of adding an Employee Assistance Program and a Health Savings Account to our benefits portfolio if budgets permit affordability.

Employee Handbook Revisions

The newly formed Employee Handbook committee met last week and Larry Hauth has graciously agreed to act as our chairperson. This committee will meet monthly for 6-7 months and our end goal is deliver a revised handbook to all employees in the Fall of 2009.

COBRA

The American Recovery and Reinvestment Act of 2009 expanded eligibility for COBRA and provides a premium reduction to certain qualified individuals. For those of you are impacted by summer layoff, we are preparing materials that you will be able to use to determine your eligibility and to better understand the reduced premium amount that you may be eligible for if you elect COBRA coverage after you leave the agency. You must be enrolled in our health plan on your last day of employment to be eligible for the premium reduction.
