At our February meeting, the Board requested a copy of the OCA's City Initiatives. I've attached a copy to this memo along with:

If, prior to taking a public stand, the Board requires consensus on the specific OCA issue but is unable to achieve it, I would like to offer an alternative for Board consideration. I would suggest that the WCCAO Board of Directors instead take a strong stand against discrimination and hate crimes. And further, that the Board denounce discrimination in all forms. including age. disability, economic status, marital status, orientation, religion, race, language and country of origin. The very people who need WCCAO's services are often the victims of discrimination and humiliating treatment. Much of what these individuals and families struggle with to achieve economic and social self sufficiency is a significant loss of self esteem. WCCAO should strongly affirm its support to all members of our community and its belief that healthy communities are those which are tolerant of differences, honor diversity, inclusive in their community culture and free of discrimination and hate crimes.

WCCAO is a part of this community and should expect to be a full fledged member. We contribute over \$3 million back to the economy and we serve thousands of the neediest who live among us. We have an obligation to be part of our community culture by contributing our values and social conscience.

If you are open to an alternative as I've described, I would be willing to draft a resolution for Board consideration. Thank you.

NOTICE OF RECEIPT OF BALLOT TITLE

Notice is hereby given that a ballot title for an initiative petition has been filed with the City Recorder of the City of Hillsboro. The ballot title does meet the requirements of Section 1 (2) (d), Article IV of the Oregon Constitution.

CAPTION:

City charter amendment to prohibit minority status for homosexuals.

QUESTION:

Shall City be prohibited from adopting and enforcing laws extending minority status to homosexuals or expending funds to promote homosexuality?

SUMMARY:

Amends City Charter. Prohibits City from extending minority status based on homosexuality, sexual orientation or preference and from enforcing such laws. Prohibits City spending to promote or approve homosexuality. Does not deny City nervices based on lawful sexual practices. Does not forbid public library materials for adults. Does not nullify civil rights based on race, religion, color, sex, marital status, familial status, national origin, age or disability. Does not limit constitutional rights. Allows laws which prohibit employment decisions based on non-work related reasons.

Any registered voter dissatisfied with the ballot title or single subject determination may petition the Washington County Circuit Court for review on or before 5:00 p.m. on February 3, 1993.
