## Shelter Provides Hope for a Brighter Tomorrow

lthough it may seem unthinkable to Thave children without a place to call home, it happens everyday, right here in Washington County. Linda Moore\*, a Hillsboro resident, knows this all too well because last year she and her three children became homeless. Linda never thought that she would end up homeless, but when the domestic violence in her home escalated, she knew that she had to leave. Because Linda was new to the neighborhood, she had no friends or safe relatives to turn to for help. Linda was at a loss. To complicate matters even further, Linda was diagnosed with Lupus, an autoimmune disorder that causes intense pain and affects various parts of the body, especially the skin, joints, blood, and kidneys. Linda felt that she had hit rock bottom until she discovered that Community Action could help.

Community Action understands that everybody needs help from time to time and welcomed Linda with open arms. "It was amazing the sense of relief that the children and I felt once we arrived at Community Action's Hillsboro family shelter. It was like a big burden was lifted. We felt warm, safe, and happier than we had felt in a long time," remembers Linda. By accessing resources made available by Community Action, Linda was able to apply for jobs, start looking for apartments, and receive encouragement and guidance from shelter staff. She was

also able to apply to HopeSpring, a partnership program of Community Action for single women and their children who have been affected by domestic violence or substance abuse. HopeSpring provided Linda with extensive support services and various educational classes to help her get back on her feet.

Today, Linda has her own apartment, works two part time jobs adding up to over 40 hours a week, and cares for her children. "Community Action really helped my family. I don't know where we would be without them. The staff at the shelter encouraged me to apply for jobs, helped build my confidence, and showed me hope for a better tomorrow." Looking back, Linda feels pride as she thinks about how hard she has worked to get where she is today. "I'm glad that I took that step to leave a bad situation in order to find something better for my family," she says.

Community Action's shelter was established in 1975 in response to the growing number of homeless children and their parents. Of the 300 people the shelter serves annually, 59% of them are children. According to Becky Smith, manager of homeless services at Community Action, one of the primary causes of homelessness is lack of social support; many families have no one to turn to in a financial crisis. "We all have times in our lives when we need support systems. Unfortunately, the people we see at our shelter don't have that support. They have no one to turn to in hard times. This is particularly true of women who have

experienced domestic violence and have limited resources."

Every year in the United States, between 2.5 and 3.5 million people experience homelessness. About half of that homeless population are families with children. In Washington County, 162 families a night are without a home. Nevertheless, most families do not stay homeless for very long, thanks to support programs such as Community Action's Family Shelter.

### A Letter to Our Friends—

Fiscal year 2001-2002 was a year to remember. A global recession was felt strongly by those of us living and working in the Pacific Northwest. Oregon led the nation in unemployment and ranked number one in "food insecurity," a measurement indicating that far too many children here were going to bed hungry. And the tragedy of those lost in the terrorist attack in New York shook Americans from coast to coast.

"What good could come from these series of events?" many of us asked ourselves. As if to answer our own question, members of the Washington County community gathered at our places of worship, with our civic groups, at our work, and within our extended families to do what we do best in trying times: help people and change lives.

Community Action, in partnership with the community, has been helping people and changing lives for nearly 40 years. During this difficult year, our community responded to the needs of our local, low-income families (many facing financial crisis for the first time in their lives) with unprecedented support and compassion.

The significantly increased community support we received last year was not entirely unexpected: many of our friends and donors have been with us from our start in the mid-60s and have worked with us through four decades of prosperous and trying economic times.

This support made the year a success. Major accomplishments include:

- Community Action's energy assistance program prevented 7,674 households from losing their heat, nearly four times as many families as in previous years.
- \$202,000 in gifts and pledges was contributed to Community Action from caring donors during two new fundraising events. A total of \$913,741 in private support was donated to compliment public grants and provide more financial flexibility to Community Action.
- The newly remodeled Hillsboro Child Development Center opened to accommodate Early Head Start. The program welcomed children birth through 5 years of age.

Compassion, community and civic pride could not have been expressed any better. Thank you so much for your continued support.

### **Local Heroes Support Community Action Programs**



Head Start children enjoyed the holidays.

Year after year, Community Action has the opportunity to partner with businesses, community groups, and individuals to help make the holiday season brighter for the children and families participating in our programs. From October through early January, holiday giving was at an all time high.

A group of employees from Intel exceeded all expectations, and hand-made the most beautiful matching glove and hat sets helping to keep 80 low-income children warm during the cold winter months. Merix Corporation, a long time partner and supporter of A Kid's Domain, adopted a Community Action program in Gaston to support the children enrolled in the full day/ full year program. Employees from Synopsys were very generous this year, adopting every family staying at the Hillsboro Family Homeless Shelter during the holidays. They provided gifts of toys, clothing, and food for each family member. Nike Consumer Affairs group adopted two Community Action Head Start classrooms for the holidays. Kid's Domain classrooms are enjoying a playhouse. Kaiser, a first time holiday donor, collected toys and classroom supplies for a Head Start classroom in Aloha while employees from the Idea Factory purchased school and art supplies for the children enrolled in the Head Start class at Metzger. South Mist Pipeline, a project of NW Natural, adopted two Head Start classes for the holidays donating school and art supplies. Community Action worked in partnership with Reliable Transmission to collect food, clothing, and cash donations for Community Action's family homeless shelter.
