 - o In 1981 we began the STEP program (the Salmon-Trout Enhancement Program) to both increase the number of fish and increase general public involvement in the project.

- o We secured funds to remodel and expand hatchery facilities in Oregon to increase overall production.
- o An increase of over 27 million fingerling salmon over the regular program for the last 3 years, to help rehabilitate wild fish runs.
- o My 1981-83 budget included over ½ million dollars for habitat improvement to increase the natural production of trout and salmon."
- --"Finally I must say that I will not support policies which endanger this critical resource. We need to know as much as possible about this resource as possible, and set appropriate seasons."
