1. What does the individual/agency do for public health within the community? Describe activities, including length of service.

In partnership with the community, Community Action assists low-income people to achieve self-determination. Community Action has been providing assistance to low-income families in Washington County since 1965, nearly 43 years. Its programs frequently provide referrals to clients for a wide range of health-related services, working with 211*info* to connect people with service providers most likely to offer assistance.

Community Action is the largest provider of Head Start preschool education in Washington County. The organization has built many strong, health-related community partnerships that are beneficial beyond measure for nearly 800 children in Head Start and Early Head Start. By learning that health is important children are more likely to pay attention to their own health as they grow. For example, brushing teeth is an essential part of each day's class in Head Start, along with eating healthy foods as part of a balanced diet. When children develop health concerns:

- Children and families are referred to private dentists who often provide services at no charge to low-income families.
- Apollo College students gain practical experience by providing health screenings in Community Action Head Start & Early Head Start Child Development Centers in Hillsboro and Beaverton.
- By diagnosing health concerns early, community partners made it more likely that children from families living in poverty will receive treatment and enjoy better health in the present as well as later in life.

Community Action's Child Care Resource & Referral program is part of a state-wide network. Community Action CCR&R:

- Refers families to Morrison Child & Family Services when children develop behavioral concerns.
- Refers low-income families without health insurance to the Essential Health Clinic, as well as the Oregon Health Plan, Women Infants & Children (WIC), and other programs related to child health.

Community Action's Opening Doors program connects low-income women without health insurance to health resources in order to ensure healthy births. The program maintains strong, on-going partnerships with:

- Women's Healthcare Associates in Tualatin.
- Tuality Healthcare.
- Virginia Garcia Clinic.
- Providence St. Vincent Hospital.

Community Action's Energy and Rent Assistance programs contribute significantly to public health in Washington County by helping people keep heat in their homes and/or avoid homelessness (public Section 8 housing may evict tenants for utility shut-offs):

- Lack of heat can contribute to pneumonia and other illnesses.
- The stress of homelessness is certainly unhealthy, as is living in a car, camping out in cold temperatures, or in unsafe, unsanitary places.

Community Action's Housing & Homeless Services program provides temporary shelter for families while they seek permanent housing. While families are in shelter the program:

- Keeps families warm, provides kitchen facilities for meal preparation, and provides food from the Oregon Food Bank, as well as local donors.
- Pays for child immunizations required for Head Start as well as public school attendance.
- Pays for prescriptions for residents of Community Action's Hillsboro Family Shelter by special arrangement with Hanks Hillsboro supermarket.

In addition to reducing high utility bills, Community Action's weatherization program reduces drafts in homes. When homes are poorly weatherized, drafts and insufficient heat can contribute to the growth and spread of viruses that can cause illness.

Community Action's Information & Referral program offers health-related information through the organization's website, or by referral to 211info. I&R also sponsors six "I&R Networking Breakfasts" each year at Community Action, to help providers learn and share information about current topics, which are often health related.

For Community Action's more than 250 staff, the organization provides an annual Wellness Day event, focusing on employee mind, body, and spiritual health.

2. What population(s) does the individual/agency assist in the community?

Community Action serves low-income residents of Washington County, most living in homes where at least one person is employed full-time. A significant number of the people Community Action assists are children under age 5, single mothers, elderly and disabled Americans.

3. Why do you believe this individual or agency should be given this award?

As a board member since February 2001, board chair 2005 - 2007, and as Regional Director for Legal Aid Services of Oregon, I, Leslea S. Smith, have become very familiar with the vital role Community Action plays in Washington County. I believe Community Action should receive the 2008 Public Health Recognition Award because the organization contributes invaluably to the public health of Washington County's low-income population, especially children and elderly citizens. Community Action deserves appropriate recognition for this important work performed professionally by its vital programs. Community Action staff apply a holistic approach to client health. Because of Community Action's excellent programs and thoughtful staff, public health in Washington County reflects Community Action's vision that: "Washington County's residents are strong, resilient, involved in the community, and live with dignity and security."
