Dear Mr. and Mrs. Nixon:

Thank you kindly for your petition and also for your letter in support of renewal of the Poverty Program.

As you know this matter is being debated now in the House. My position on this matter has been misrepresented. My objections to the Poverty Program to date have centered on the extremely high costs of administration. There are more supergrade high-salaried employees in the OEO right here in Washington than in any other government agency except the Space Agency where scientists are employed. In all too many cases these jobs are in the hands of political hacks. Far too much of the appropriation money is wasted in administration costs and too little of the money is available for the good programs of the OEO which are rapidly improving.

The status of the entire bill on the Floor of the House is in grave doubt. I certainly shall do nothing to kill the program but during the debate and the consideration of literally hundreds of amendments which will be offered, I hope to participate in improving the administration of this program.
