EDITORIAL - THE ANNUAL ELECTION MEETING

Elsewhere in this newsletter is the announcement of our annual election of Board Members. This election meeting is the most important single meeting of our entire Washington County "War-on-Poverty" program. All who read this newsletter and who are citizens of Washington County should make it their solemn duty to attend this election meeting!

Some may ask, "what is so important about this meeting? There are many public groups involved in this or that community service. How is the Community Action Organization different?" I beg you read carefully my reply to this significant question.

I could point out that we are a corporation and the Board Members are tha legal body which owns and operates the Community Action Organization. If the Board does not function, our whole offort in reducing economic and cultural poverty stops--we close the office.

It is necessary to remember that the Board of Directors is the direct contact between our local efforts and the Federal Government from which most of our funds are obtained. The Office of Economic Opportunity will deal only with the official actions of our Board.

But of crucial concern is that through our Board, made up of a cross-section of County citizens--citizens from all walks of life-we maintain control of our own affairs. It is this last reason which makes the coming election meeting so important. If own life experiences as well as all that has happened in the "War-on-Poverty" program dictates that the success we have in eliminating poverty in Washington County will come out of our own efforts. It is our County, our neighborhoods. The low intore and distressed folks among us are our neighbors, friends, comployees--our fellow citizens. They are part of us. No federal government can solve our problems or successfully carry our responsibilities. We have to do the job ourselves. CAP NEWS

Only as we understand our own needs, develop a plan for solving them and take on the actual job of helping our fellow citizens become more effective in living with dignity as American citizens, will real progress be made. Quite frankly, all the Federal Government can do to help is to provide some of the financial means for our work and even here, if we become dependant up. on the government for funds, we lose a part of our ability to solve our own problems. We also lose in personal dignity as we give up some of our freedom to the dictates of government bureaus.

If our Board of Directors do not find an effective way to work, the Federal Government will come in with their canned programs, directives, paperwork and delays. There never has been any roal success in solving problems of poverty when a community takes the federal government route. We need a dedicated body of men and women--citizens of Washington County--who will accept the challenge of solving our problems of poverty right here in the County. The annual election meeting is where that group of citizens are formed--where the citizens of the county re-affirm their belief in the dignity of men and in the American tradition of freedom of opportunity for all citizens of our great nation.

UPWARD BOUND PROJECT AT PACIFIC UNIVERSITY

For the second consecutive year, Pacific University is conducting an Upward Bound Project through the pre-college program of the O.E.O. This year's project involves 51 high school students from the Washington County and Portland areas. These boys and girls have completed their sophomore or junior year in high school and are all returning to high school this fall. They must all meet O.E.O. income standards and must have demonstrated academic potential for college study. The primary purpose of the program is to encourage and assist these students in their school performances and enable them to enroll in a college or technical school.

The program is divided into two phases, the first of which is the residency phase. For seven weeks, the students lived on the Pacific University Campus. Small classes, facilitating close student-teacher relationships, were held in such subjects as Math, English, Science and the Arts. A Reading Improvement program was also conducted. Trained leaders provided opportunities and guidance in varied recreational activities. In addition, the students were taken on educational/cultural tours and on pleasure trips to such palces as State Parks and the beach. The second phase, the follow-up phase of the program, consists of maintaining contact with the students in their respective schools and assisting them as needed. A regular tutoring program is provided. The Upward Bound staff works closely with school personnel and with other social agencies in order to help these students realize the greatest possible development of their potential.
